**PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR
COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND
RESETTLEMENT ACT, 2013 (ACT 30 OF 2013).**

Whereas, it appears to the Governor that land is likely to be needed for a public purpose, namely for construction of BOP at Dombang by 11th Bn ITBP Force, Pegong, Ministry of Home Affairs, Government of India, in the block of Lachung District Mangan, North Sikkim. It is hereby notified that the several pieces of land comprising cadastral plots mentioned under the "**Schedule of Properties**" below and measuring more or less **0.9100 hectares** (Private Land) is likely to be needed for the aforesaid public purpose at public expense, within the aforesaid block of Lachung, North Sikkim.
