**DECLARATION UNDER SECTION 19 OF RIGHT TO FAIR COMPENSATION AND  
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT,  
2013 (ACT 30 OF 2013).**

Whereas, vide Preliminary Notification No.10/LR&DMD/2025 dated 26/09/2025, Gazette Notification No.414 dated: 03/11/2025 was notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the Schedule hereto, thereafter referred to as the said land were required or likely to be required for the purpose, namely for the construction of an Acclimatization Center at Chaten by the 11<sup>th</sup> Bn, ITBP Force Pegong, Ministry of Home Affairs, Government of India in the block of Lachen, North Sikkim based on the field report submitted by Sub Division Office, Chungthang.

And whereas, the preparation of the mandated Rehabilitation and Resettlement Scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19 (I) of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said lands are required for aforementioned public purpose, in the block of Chungthang, Mangan District.

**Lachen Revenue Block:**

Private Land bearing Plot Nos. 1910 & 1911 measuring more or less are 1.6840 hectares and boundaries may be read as:
