NOTIFICATION

PRELIMINARY NOTIFICATION UNDER SECTION 11(1) OF RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013 (ACT 30 OF 2013)

Whereas, it appears to the Governor that land is likely to be needed for a public purpose, namely for the purpose of improvement and muck dumping along Mangan-Sankalang by Border Road Organization 107 RCC GREF in the revenue blocks of Zimchung, Malling-Singhik and Kazor, Mangan District. It is hereby notified that several pieces of land comprising cadastral plot nos. mentioned under the "**Schedule of Properties**" below and measuring more or less area **4.8352** hectares (Private Land) and **0.4200** hectares (Sikkim Sarkar Khasmal) measuring total area **5.2552** hectares is likely to be needed for the aforesaid public purpose at the public expense, within the aforesaid blocks of Zimchung, Malling-Singhik and Kazor, Mangan District.
